Release, Rental & Indemnity

I / We confirm to participate in any or all the activities at THE WILD TRIBE RANCH like ZIP LINER (FLYING FOX), PAINT BALL (TOTEM CHROMA), DESCENDER, ALL TERRAIN VEHICLE (MAD RIDERS) & OTHER ACTIVITIES with understanding of the below that have been enumerated for my / our safety & well being.

1. Zip Liner, Descender & Paintball are physically & mentally intense; where as All Terrain Vehicles is physically intense.
2. The paint balls travel at a range of 235ft & above per second; they will / may leave a bruise. They can also cause hurt and damage if not played in accordance to the safety norms.
3. In Game of paint ball clothing may be stained by the paintballs.
4. The game of Paint Ball, ride in All Terrain Vehicles & attempting Descender, Zip Liner can be dangerous if not played in accordance with the stated rules which has been detailed by Wild Tribe guides on duty or as mentioned in the RULES & REGULATIONS charts and safety boards.
5. The possibility of injury to my son / daughter and members in my group does exist in the activities of THE WILD TRIBE RANCH.
6. Playing game of Paint Ball, ride in All Terrain Vehicle, attempting Descender, Zip Liner & taking part in other activities is only for the pleasure and experiencing an adventure sport and I confirm that I do not have any ulterior motive.
7. I / We also confirm and agree my son / daughter:
 - a. Is aware of the risks involved in the games & activities at THE WILD TRIBE RANCH
 - b. Is physically fit and able to take the exertion of the games & activities at THE WILD TRIBE RANCH.
8. I / We will comply with Wild Tribe rules and use the equipment as instructed and not so as to injure others and will obey all directions of the Wild Tribe Guides.
9. The Wild Tribe Ranch has the right to use the footage from its CCTV footage, photos taken by our official photographer for its collaterals, promotions or any official communications.
10. In game of Paint Ball and a ride in ATV I / we have to wear the goggles / face mask / helmets and never remove them when NOT IN SAFE ZONE even if they mist over or gets covered in paint / dust. I am aware that removing the safety guard or mask while not in safe zone could cause injury to any part of my face and upper torso.
11. I / We will wear and use their safety equipment like facemask (goggles), Chest Guard, Harness, Helmets and others as required in Paint Ball, All Terrain Vehicle, Zip Liner, Devil's Ramp, Descender & other activities in The Wild Tribe Ranch, failing which we could be expelled from the activity by the duty guides.
12. I / We will use the swimming pool with suitable swim wear and shall not enter into the swimming pool with open ailments or with contagious health ailments.
13. I / We will follow eligibility, safety norms of The Wild Tribe Ranch; we understand that they are for my / our safety & well being.
14. I / We understand that coupon system is given to have alternative choice of activities in situations of any breakdown or maintenance of activities that may arise, I / we are aware that under these or any circumstances we shall not receive any refund for unused coupons and agree that we shall consume them during the given date.

Release and Rental:
